

# Alabama

## To sign your Alabama title:

- Turn your title over to the backside.
- Find the “assignment of title by registered owner” box. You should see it near the top of the page.
- In that box, find “signature of sellers”.
- Sign on this line. The title must be signed exactly as your name reads on the front of the title under “name and mailing address of owner”, including middle initials, etc.
- All owners on the front of the title must sign on this line.

**BACK SIDE:** FEDERAL and State law requires that you state the mileage in connection with transfer of ownership. Failure to complete ODOMETER STATEMENT OR providing a FALSE STATEMENT may result in fines and/or imprisonment.

**To sign your Alabama Power of Attorney:**

- Take the form to a notary.
- Find “signature of owner” halfway down the page. There is a triangle pointing to the line.
- Sign on this line exactly as your name appears on the title. All names that are listed as owners on the title must sign on this line.
- \*\*\*This must be signed in front of a notary and notarized.\*\*\*

If a business firm or corporation is appointed, the signature shall be of an authorized representative of the firm who will perform as attorney-in-fact for the owner.

**SPECIAL NOTICE:** Any alterations or strikeovers shall void this Power of Attorney. Original signatures are required on all Power of Attorneys.

**LEGAL NOTICE:** A person acting for the motor vehicle owner under this Power of Attorney should be aware of the statute under the Alabama Uniform Certificate of Title and Antitheft Act as follows: Code of Alabama 1975, §32-8-11. "Aiding, abetting, etc., in violations. A person who, whether present or absent, aids, abets, induces, procures or causes the commission of an act which if done directly by him, would be a felony or a misdemeanor under provisions of this chapter, is guilty of the same felony or misdemeanor. (Acts 1973, No. 785, p. 1147, §43.)"
