## To sign your Indiana title

- On the front of the title, find the box showing “seller must complete”
- Within this box, find “signature of seller”
- Sign in this box. All names that are listed under “owners name and address” must sign here exactly as listed, including middle initials, etc.

You must apply for a new certificate of title within thirty-one days of purchase, or pay a reinstatement penalty of \$70.00. All fees shown on the face of this title must be received before you apply for a new title. Take this to your local DMV. Local branch to complete your application for a new title.
