

# Missouri

## To sign your Missouri title:

- Turn your title to the back side
- Find the box that states “assignment” along the left side
- Within this box, find the box that states “signature of all sellers”
- Sign in this box. All names that are listed on the front under “owner” must sign here exactly as listed, including middle initials, etc.
- Print your name below in the box that reads “hand printed name by seller”

## Example:

## To sign your secure Missouri Power of Attorney form 3020s

- Locate box that states, “all sellers must sign and hand print their names in the space provided”
- Below that box, the box that states “sellers signature” needs to be signed. All names that are listed as owners on the title must sign in this box.
- Also print your name in the box that states “sellers printed name” and write your address in “street address” and “city, state, zip code” box.

Anytime a Secure Power of Attorney is used, the Missouri purchasing dealer must either: 1. Apply for title in the dealership's name, surrendering the Secure Power of Attorney with their application for title; or 2. The dealer may avoid retitling the vehicle by submitting the secure carbon copy of this power of attorney form and a copy of the front and back of the corresponding certificate of title to the Driver and Vehicle Services Bureau with the dealer's monthly sales reports. In this case, the dealer must give the subsequent purchaser the original/top copy of the Secure Power of Attorney which must accompany the certificate of title. ## To sign Missouri Power of Attorney form 4054

- Take this form to a notary.
- Find the box that states “owner signature”
- Sign in this box. All names that are listed on the title must sign here exactly as listed, including middle initials, etc.
- \*\*\*This must be signed in front of a notary and notarized.\*\*\*
